Ecology Search – Faculty ranking results (Steve Matson)

- Buckley received the majority of the 1st rank votes with Hurlbert a close second.
- Johnson received no 1st rank votes.
- Conclusion: Buckley is the choice of the majority

Search Committee (Joel Kingsolver)

- Move to make an offer to Buckley, also consider Hurlbert if Buckley declines.
 - o Buckley is stronger quantitatively and mathematically.
- Discuss potential for two offers: Buckley & Hurlbert
 - o Enthusiasm high for both candidates, both make excellent compliments.

Open Discussion: Potential for two offers

Charles Mitchell: A lot of discussion was necessary to reach a consensus with the committee. Elaine Yeh: Inquire about excitement for Buckley & Hurlbert versus the two candidates that withdrew.

Joel Kingsolver: People have a lot of excitement for both.

Mark Peifer: Many senior ecology people are not present to help make this important decision.

David Pfennig: These are two amazing people. Ecology is an area in the dept. that needs new hires and both are good candidates. This is a very good opportunity.

Joel Kingsolver: Bob Peet is a strong supporter of Hurlbert. Thus, senior ecology faculty are likely to agree with the plan.

Ken Lohmann: Will this complete ecology's needs for the next five years?

Seth Reice: As long as they fulfill distinct valuable needs for the dept. it is a good idea.

Pat Gensel: They will add strengths to the dept in growing areas of ecology.

Sabrina Burmeister: Both candidates have 2nd offers, we cannot delay the process.

Charles Mitchell: The search committee sorted through 174 candidates that would

complement the department – a broad net was cast and two strong candidates have been identified –both are worthy of being in the department.

Ken Lohmann: Who will the candidates interact with in the dept.?

Response: Hurlbert would interact with Reice, White, Peet and Jones. Both candidates will bridge the gap between community and population biology.

Karin Pfennig: Candidates bridge the fields of ecology, organismal and evolutionary biology David Pfennig: This is the first ecology search in 12 years. This is a great opportunity to take care of this major area of biology.

Mark Peifer: New, young people are needed in the department to cover ecology. Senior people will be retiring.

Conclusion (Steve Matson)

Motion:

- Proceed with an offer to Buckley and arrange a second visit.
- Hurlbert will be 2nd in line.
- Steve Matson will talk to Bruce Carney about a second position, examine resources available and decide if a 2nd offer is feasible.
